Short Tender Notice

Tender for the consultancy services for preparation of pre-feasibility study report for the development of Commercial Helicopter Services in Bihar under PPP mode.

1. Infrastructure Development Authority intends to develop Commercial Helicopter Services in Bihar under PPP mode.
2. In view of the above, pre-feasibility rates are invited.
3. Consultant should have minimum 15 years experiences in the field of Aviation infrastructure.
4. One firm will be selected on the basis of lowest quoted rate (L1) as pre-feasibility fee.
5. Consultant shall be responsible for preparation of pre-feasibility study report for above mention project.
6. Scope of Work for preparation of feasibility study shall include:
 - What type of helicopter is best suited for the work.
 - What is the budgetary provisions required for meeting the helicopter services.
 - Consideration of options including ownership/hire/lease.
 - In case of ownership, options would include (i) Direct ownership (ii) Shared ownership (iii) Fractional ownership.
 - The helicopter services may be outsourced to Commercial Operators. If so the routes.
 - In case of ownership/charter, the study would bring out comparative cost of various types of helicopters available in the market.
 - What are operational expenses?
 - Is the aviation infrastructure needs to be set up? If so where.
 - What is the downside in owning a helicopter?
 - Is it possible to share ownership and still get tax depreciation on the part share?
 - In case of ownership, details of maintenance and admin support required in keeping with flight safety and operating ambience would be covered in the study.
7. The pre-feasibility report should be developed by an experienced team consisting of at least two experts who should have experience in helicopter services. The CVs should be submitted to IDA after award of the project.
8. The format for submission of pre-feasibility rate is enclosed as annexure A. Pre-feasibility rates shall be submitted in Hard Copy in a sealed envelope and should be addressed to:
