1. This Invitation for Bid follows the General Procurement Notice for this Project that appeared in Development Business on 9th March, 2017
2. The Government of India has received financing aid from the World Bank towards the cost of National Hydrology Project and intends to apply a part of the funds to cover eligible payments under the contracts for construction of works as detailed below. Bidding will be conducted through National Competitive Bidding procedures agreed with the World Bank. Bidding is open to all eligible bidders as defined in the World Bank's Guidelines. Bidders from India should, however, be registered with State Governments/Government of India/ Central procurement Agencies) who are not registered as above, on the date of bidding, can also participate provided they get themselves registered by the time of contract signing, if they become successful bidders. **Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract.** In addition, please refer to paragraphs 1.6 and 1.7 of the World Bank's Guidelines setting forth the World Bank's policy on conflict of interest.
3. The Executive Engineer (P.D.A.) / Nodal Officer invites online bids for the construction of works detailed below in the table. The bidders may submit bids for any or all of the works indicated therein.
4. Bids must be accompanied by security of the amount specified for the work in the table below, drawn in favour of Executive Engineer (P.D.A.) / Nodal Officer. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 60 days beyond the validity of the bid. The validity of the bid will be 90 days from the actual date of opening date of bid. **In case the last date of submission of bid has been extended, 90 days shall be counted from extended date. Any tender valid for a shorter period shall be treated as unresponsive and rejected.**
5. Bids must be submitted online www.eproc.bihar.gov.in on or before 15.00 hours on 13.11.2019 and technical bid will be opened online on 13.11.2019 at 15.30 .hours, in the presence of the bidders designated representatives who wish to attend. If the office happens to be closed on the opening date of the bids as specified, the bids will be opened on the next working day at the same time and venue. Only online bidding is permitted.
6. A pre-bid meeting will be held on 19.10.19 at 15.00 .hrs. at the office of Executive Engineer (P.D.A.) / Nodal Officer to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in ITB Clause 7.4 of 'Instructions to Bidders' of the bidding document.
